Family Child Care Providers



What is the Child Care Food Program?

The Child and Adult Care Food Program (CACFP) is funded by the United States Department of Agriculture (USDA) and is overseen by the California Department of Social Services (CDSS).

Catalyst Community acts as a sponsor to child care providers to help children in childcare homes receive nutritious meals. Exposure to good nutrition at an early age benefits children by promoting healthful eating habits that last a lifetime.

Catalyst Community reimburses licensed family child care providers and licensed exempt (Trustline) providers for meals and snacks served to children zero through twelve years of age.

What is required to participate?

Participating in the Catalyst Community Child Care Food Program is easy.

- Providers serve meals and snacks to children according to the USDA Meal Pattern Requirements.
- Meals and snacks are recorded daily using KidKare, a free, easy to use online computer program which can be used on a tablet or smartphone as well.
- ✓ At the end of each month, providers submit their claim electronically and then are reimbursed for the meals and snacks claimed according to the current reimbursement rates.
- ✓ Cash reimbursement is issued monthly for the previous month's meals.
- ✓ Providers also receive an informative monthly newsletter with menu ideas.

How much is the reimbursement for Family Child Care Providers?

Federal Reimbursement Rates

Maximum reimbursement is: 2 mail meals + 1 snack per child per day.

Breakfast \$1.65 \$0.59
Lunch/Dinner \$3.12 \$1.88
Snack \$0.93 \$0.25

*Tier level is determined at initial training and is based on eligibility by income and/or school.
